Who we are

What data do we collect?

Our Company collects the following data:

- Personal identification information (Name, email address, phone number, etc.)
- Personal asset and liability information
- Personal income and expenditure data
- Personal bank statements
- Details of your professional advisors

How do we collect your data?

You directly provide Our Company with most of the data we collect. We collect data and process data when you:

- Complete a client fact find document
- Provide information / documents we request from you to assist our credit broking
- Provide feedback or answer questions we ask via email
- Use or view our website via your browsers cookies
- Voluntarily complete a customer survey or provide feedback on any of our message boards or via email.
- Use or view our website via your browser's cookies.

Our Company may also receive your data indirectly from the following sources:

- Experian or similar credit reference agency

How will we use your data?

Our Company collects your data so that we can:

- Process your application and manage your request.
- Provide an accurate recommendation for your current circumstances

When Redgate processes your data, it may send your data to, and also use the resulting information from, credit reference agencies to prevent fraudulent purchases.

We may pass your data to our panel of lenders to enable them to consider your lending application.



How do we store your data?

Our Company securely stores your data at The Bake House, 13B Holmesdale Road, Reigate, Surrey, RH2 0BA. Your electronic data is stored via Google Drive cloud storage based system using 2 factor authentication to provide secure access to personal information.

Our Company will keep your data for six years. Once this time period has expired, we will delete your data from our storage device.

Marketing

Redgate will not market you or share your data with third party marketing agencies.

What are your data protection rights?

Redgate would like to make sure you are fully aware of all of your data protection rights. Every user is entitled to the following:

The right to access – You have the right to request Our Company for copies of your personal data. We may charge you a small fee for this service.

The right to rectification – You have the right to request that Our Company correct any information you believe is inaccurate. You also have the right to request Our Company to complete the information you believe is incomplete.

The right to erasure – You have the right to request that Our Company erase your personal data, under certain conditions.

The right to restrict processing – You have the right to request that Our Company restrict the processing of your personal data, under certain conditions.

The right to object to processing – You have the right to object to Our Company's processing of your personal data, under certain conditions.

The right to data portability – You have the right to request that Our Company transfer the data that we have collected to another organisation, or directly to you, under certain conditions.
